



**2018 TLClocals hosted Beach Clean-Ups
Waiver of Liability and Express Assumption of Risk**

FAMILY VOLUNTEERS

As a participant of a TLClocals hosted Beach Clean-Up (“Event”), I agree as follows: I am volunteering my services for the Event; I will perform assigned tasks that are within my physical capability and I will not undertake tasks that are beyond my ability; I will not participate if under the influence of alcohol or any drug that could impair my physical or mental abilities; I am familiar with the safe operation and use of any machinery, equipment and tools that I may utilize in connection with the Event, and I will not undertake to use any machinery, equipment or tools with which I am unfamiliar or which I do not know how to operate safely; I have received appropriate instruction regarding this Event, including appropriate safety and emergency procedures, I fully understand those instructions and I agree to only use supplies provided by Event organizers after I have inspected them and deemed them safe for use; I specifically acknowledge that I am engaging in this activity as a volunteer and not as an employee of TLClocals or any of its partner or sponsor organizations and further acknowledge that I am not entitled to any compensation, benefit or insurance coverage from TLClocals or any of its partner or sponsor organizations, nor will I make such claim.

I understand and agree that neither TLClocals or any of its partner or sponsor organizations, nor any of their respective employees, officers, agents or assigns, (collectively referred to as “Released Parties”), may be held liable or responsible in any way for any injury, death or other damages to me or my family, heirs, or assigns that may occur as a result of my participation in the Event, or as a result of product liability or the negligence, whether passive or active, of any party, including Released Parties, in connection with the Event.

I understand that cleaning up beaches or inland water areas involves certain inherent risks, including but not limited to, the risks of possible injury, infection or loss of life as a result of contact with trash or other hazardous materials, animals and insects, poisonous plants, bacteria, over-exertion, dangerous terrain or environmental conditions. Despite the risks, I still choose to participate in this activity.

No known physical or health limitation prevents me from safely participating in this Event. In consideration for being allowed to participate, I personally assume all risks, whether foreseen or unforeseen, in connection with the Event of any harm, injury or damage that may befall me as a participant.

If I am injured during the Event, I authorize any physician licensed in California to perform such emergency treatment as he or she believes, in his or her sole judgement, may be necessary. I am over the age of eighteen and legally competent to sign this liability release, or I have acquired the written consent of my parent or guardian. I understand that the terms herein are contractual and not a mere recital, this instrument is legally binding and I have signed this document of my own free act.

I hereby release and hold harmless TLClocals and the Released Parties from any claim or lawsuit for personal injury, property damage, property loss or wrongful death, by me, my family, estate, heirs, or assigns, arising out of the participation in the Event, including both claims arising during the activity and after I complete the activity and including claims based on negligence of other participants or the released parties, whether passive or active.

I have fully informed myself of the contents of this liability release and assumption of risk and am signing on my own behalf or on the behalf of a minor as their parent or legal guardian. If signing as a parent or legal guardian, I acknowledge I have read and agree to the above for myself and/or my minor participant and further understand and agree that TLClocals and the partners and sponsors of the Event are not responsible for supervision of minor participant/s and that if I allow the above minor/s to participate without my supervision, I assume all the risks from such participation.

I confirm I have read and understand the liability waiver and agree to participate and/or have my minor child/children participate in this and future Beach Clean-Ups.
